1. Foreword

Article 62, paras. 62.2, 62.3 and 62.4 of the Natural-Gas Market Rules (hereafter “Rules”) provides that, under the emergency conditions mentioned in para. 62.1 subpara. a), b), c) and d) of the same article, GME’s communications shall take place as described in the Technical Rules.

Article 62, para. 62.6 of the Rules provides that GME shall notify Market Participants of the actions undertaken under para. 62.4 subpara. a) and b) of the same article, in accordance with the modalities indicated in the Technical Rules.

2. Management of connections to the SIMGAS¹ portal

Market Participants may check the status of the Internet connection to the SIMGAS by accessing the “Mostra Mercati” (show markets) application (available at <http://siti.ipex.it>), which lists all the Internet addresses, both ordinary and emergency ones, through which they may log onto GME’s electronic platforms.

3. Emergency communications between GME and Market Participants

As specified in Article 62, para. 62.2 of the Rules, if GME is unable to receive bids/offers or cancellation requests submitted by Market Participants, it will notify Market Participants and, in case that the emergency condition concerns the receipt of bids/offers, Snam Rete Gas or each storage company if relevant to the MGS, of the above condition (and of the new time of opening of the MGAS trading session) with electronic means in accordance with Article 10, paragraph 10.1 of the Rules. If, by the new time of opening of the market session, the above malfunctions persist, GME will suspend the session and notify Market Participants, Snam Rete Gas or each storage company if relevant to the MGS thereof in compliance with article 10, para. 10.1 of the Rules.

If GME is unable to determine the results of a market session or to carry out the admissibility checks of a cancellation request, or to notify Market Participants and, in reference to MGAS only, storage companies of the results of a market session, or the results of a cancellation request, it will - under art. 62, para. 62.3 of the Rules - suspend such session of the MGAS, notifying Market Participants and, in case that the emergency condition concerns the determination and communication of

results, Snam Rete Gas or each storage company if relevant to the MGS thereof in compliance with article 10, para. 10.1 of the Rules.

If the net positions referred to in article 26 of the Rules cannot be registered at the PSV, GME will - under art. 62, para. 62.4 of the Rules - notify Market Participants of the above condition and, where possible, of its duration in compliance with article 10, para. 10.1 of the Rules.

GME will notify Market Participants of the actions undertaken under article 62, para. 62.4 a) and b) of the Rules in accordance with article 10, para. 10.1 thereof.
